| <p>A mixture consists of two or more elements or compounds not chemically combined together. The chemical properties of each substance in the mixture are unchanged.</p> <p>Mixtures can be separated by physical processes such as filtration, crystallisation, simple distillation, fractional distillation and chromatography. 4.1.1.3 The development of the model of the atom (common content with physics)

| <p>New experimental evidence may lead to a scientific model being changed or replaced.</p> <p>Before the discovery of the electron, atoms were thought to be tiny spheres that could not be divided.</p> <p>The discovery of the electron led to the plum pudding model of the atom. The plum pudding model suggested that the atom is a ball of positive charge with negative electrons embedded in it.</p> <p>The results from the alpha particle scattering experiment led to the conclusion that the mass of an atom was concentrated at the centre (nucleus) and that the nucleus was charged. This nuclear model replaced the plum pudding model.</p> <p>Niels Bohr adapted the nuclear model by suggesting that electrons orbit the nucleus at specific distances. The theoretical calculations of Bohr agreed with experimental observations.</p> <p>Later experiments led to the idea that the positive charge of any nucleus could be subdivided into a whole number of smaller particles, each particle having the same amount of positive charge. The name proton was given to these particles.</p> <p>The experimental work of James Chadwick provided the evidence to show the existence of neutrons within the nucleus. 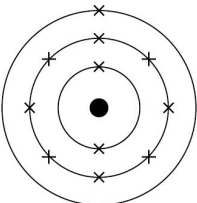

| <p>Before the discovery of protons, neutrons and electrons, scientists attempted to classify the elements by arranging them in order of their atomic weights.</p> <p>The early periodic tables were incomplete and some elements were placed in inappropriate groups if the strict order of atomic weights was followed.</p> <p>Mendeleev overcame some of the problems by leaving gaps for elements that he thought had not been discovered and in some places changed the order based on atomic weights.</p> <p>Elements with properties predicted by Mendeleev were discovered and filled the gaps. Knowledge of isotopes made it possible to explain why the order based on atomic weights was not always correct.</p> <p>Students should be able to describe these steps in the development of the periodic table.</p> | <p>WS 1.1, 1.6</p> <p>Explain how testing a prediction can support or refute a new scientific idea.</p> |

The noble gases have eight electrons in their outer shell, except for helium, which has only two electrons.</p> <p>The boiling points of the noble gases increase with increasing relative atomic mass (going down the group).</p> | |

4.2 Bonding, structure, and the properties of matter

Chemists use theories of structure and bonding to explain the physical and chemical properties of materials. Analysis of structures shows that atoms can be arranged in a variety of ways, some of which are molecular while others are giant structures. Theories of bonding explain how atoms are held together in these structures. Scientists use this knowledge of structure and bonding to engineer new materials with desirable properties. The properties of these materials may offer new applications in a range of different technologies.

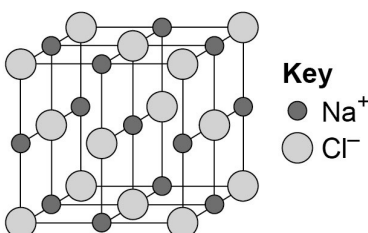
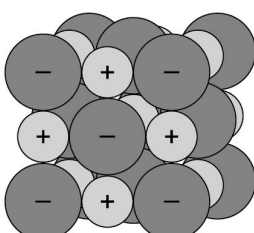
4.2.1.1 Chemical bonds

| <p>There are three types of strong chemical bonds: ionic, covalent and metallic. For ionic bonding the particles are oppositely charged ions. For covalent bonding the particles are atoms which share pairs of electrons. For metallic bonding the particles are atoms which share delocalised electrons.</p> <p>Ionic bonding occurs in compounds formed from metals combined with non-metals.</p> <p>Covalent bonding occurs in most non-metallic elements and in compounds of non-metals.</p> <p>Metallic bonding occurs in metallic elements and alloys.</p> <p>Students should be able to explain chemical bonding in terms of electrostatic forces and the transfer or sharing of electrons.</p> | |

| <p>When a metal atom reacts with a non-metal atom electrons in the outer shell of the metal atom are transferred. Metal atoms lose electrons to become positively charged ions. Non-metal atoms gain electrons to become negatively charged ions. | <p>The three states of matter are solid, liquid and gas. Melting and freezing take place at the melting point, boiling and condensing take place at the boiling point.</p> <p>The three states of matter can be represented by a simple model. In this model, particles are represented by small solid spheres. Particle theory can help to explain melting, boiling, freezing and condensing.</p> <div style="display: flex; justify-content: space-around; align-items: center;">    </div> <div style="display: flex; justify-content: space-around; align-items: center;"> Solid Liquid Gas </div> <p>The amount of energy needed to change state from solid to liquid and from liquid to gas depends on the strength of the forces between the particles of the substance. The nature of the particles involved depends on the type of bonding and the structure of the substance. 4.2.2.3 Properties of ionic compounds

| <p>Ionic compounds have regular structures (giant ionic lattices) in which there are strong electrostatic forces of attraction in all directions between oppositely charged ions.</p> <p>These compounds have high melting points and high boiling points because of the large amounts of energy needed to break the many strong bonds.</p> <p>When melted or dissolved in water, ionic compounds conduct electricity because the ions are free to move and so charge can flow.</p> <p>Knowledge of the structures of specific ionic compounds other than sodium chloride is not required.</p> | |

4.2.2.4 Properties of small molecules

| Content | Key opportunities for skills development |

| <p>Substances that consist of small molecules are usually gases or liquids that have relatively low melting points and boiling points.</p> <p>These substances have only weak forces between the molecules (intermolecular forces). It is these intermolecular forces that are overcome, not the covalent bonds, when the substance melts or boils.</p> <p>The intermolecular forces increase with the size of the molecules, so larger molecules have higher melting and boiling points.</p> <p>These substances do not conduct electricity because the molecules do not have an overall electric charge.</p> <p>Students should be able to use the idea that intermolecular forces are weak compared with covalent bonds to explain the bulk properties of molecular substances.</p> | WS 1.2 |

4.2.2.5 Polymers

| <p>Polymers have very large molecules. The atoms in the polymer molecules are linked to other atoms by strong covalent bonds. The intermolecular forces between polymer molecules are relatively strong and so these substances are solids at room temperature.</p> <p>Students should be able to recognise polymers from diagrams showing their bonding and structure.</p> | |

4.2.2.6 Giant covalent structures

| <p>Substances that consist of giant covalent structures are solids with very high melting points. All of the atoms in these structures are linked to other atoms by strong covalent bonds. These bonds must be overcome to melt or boil these substances. Pure metals are too soft for many uses and so are mixed with other metals to make alloys which are harder.</p> | |

4.3 Quantitative chemistry

Chemists use quantitative analysis to determine the formulae of compounds and the equations for reactions. Given this information, analysts can then use quantitative methods to determine the purity of chemical samples and to monitor the yield from chemical reactions.

Chemical reactions can be classified in various ways. Identifying different types of chemical reaction allows chemists to make sense of how different chemicals react together, to establish patterns and to make predictions about the behaviour of other chemicals. Chemical equations provide a means of representing chemical reactions and are a key way for chemists to communicate chemical ideas.

4.4 Chemical changes

Understanding of chemical changes began when people began experimenting with chemical reactions in a systematic way and organizing their results logically. Knowing about these different chemical changes meant that scientists could begin to predict exactly what new substances would be formed and use this knowledge to develop a wide range of different materials and processes. It also helped biochemists to understand the complex reactions that take place in living organisms. The extraction of important resources from the earth makes use of the way that some elements and compounds react with each other and how easily they can be 'pulled apart'.

4.5 Energy changes

Energy changes are an important part of chemical reactions. The interaction of particles often involves transfers of energy due to the breaking and formation of bonds. Reactions in which energy is released to the surroundings are exothermic reactions, while those that take in thermal energy are endothermic. These interactions between particles can produce heating or cooling effects that are used in a range of everyday applications. Some interactions between ions in an electrolyte result in the production of electricity. Cells and batteries use these chemical reactions to provide electricity. Electricity can also be used to decompose ionic substances and is a useful means of producing elements that are too expensive to extract any other way.

4.6 The rate and extent of chemical change

Chemical reactions can occur at vastly different rates. Whilst the reactivity of chemicals is a significant factor in how fast chemical reactions proceed, there are many variables that can be manipulated in order to speed them up or slow them down. Chemical reactions may also be reversible and therefore the effect of different variables needs to be established in order to identify how to maximise the yield of desired product. Understanding energy changes that accompany chemical reactions is important for this process. In industry, chemists and chemical engineers determine the effect of different variables on reaction rate and yield of product. Whilst there may be compromises to be made, they carry out optimisation processes to ensure that enough product is produced within a sufficient time, and in an energy-efficient way.

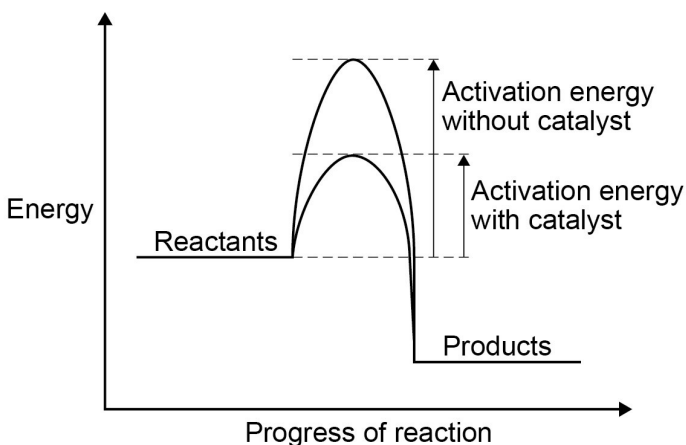

4.7 Organic chemistry

The chemistry of carbon compounds is so important that it forms a separate branch of chemistry. A great variety of carbon compounds is possible because carbon atoms can form chains and rings linked by C-C bonds. This branch of chemistry gets its name from the fact that the main sources of organic compounds are living, or once-living materials from plants and animals. These sources include fossil fuels which are a major source of feedstock for the petrochemical industry. Chemists are able to take organic molecules and modify them in many ways to make new and useful materials such as polymers, pharmaceuticals, perfumes and flavourings, dyes and detergents.

4.8 Chemical analysis

Analysts have developed a range of qualitative tests to detect specific chemicals. The tests are based on reactions that produce a gas with distinctive properties, or a colour change or an insoluble solid that appears as a precipitate.

Instrumental methods provide fast, sensitive and accurate means of analysing chemicals, and are particularly useful when the amount of chemical being analysed is small. Forensic scientists and drug control scientists rely on such instrumental methods in their work.

4.9 Chemistry of the atmosphere

The Earth's atmosphere is dynamic and forever changing. The causes of these changes are sometimes man-made and sometimes part of many natural cycles. Scientists use very complex software to predict weather and climate change as there are many variables that can influence this. The problems caused by increased levels of air pollutants require scientists and engineers to develop solutions that help to reduce the impact of human activity.

4.9.1 The composition and evolution of the Earth's atmosphere

4.10 Using resources

Industries use the Earth's natural resources to manufacture useful products. In order to operate sustainably, chemists seek to minimise the use of limited resources, use of energy, waste and environmental impact in the manufacture of these products. Chemists also aim to develop ways of disposing of products at the end of their useful life in ways that ensure that materials and stored energy are utilised. Pollution, disposal of waste products and changing land use has a significant effect on the environment, and environmental chemists study how human activity has affected the Earth's natural cycles, and how damaging effects can be minimised.

4.10.2.2 Ways of reducing the use of resources

| <p>The reduction in use, reuse and recycling of materials by end users reduces the use of limited resources, use of energy sources, waste and environmental impacts.</p> <p>Metals, glass, building materials, clay ceramics and most plastics are produced from limited raw materials. Much of the energy for the processes comes from limited resources. Obtaining raw materials from the Earth by quarrying and mining causes environmental impacts.</p> <p>Some products, such as glass bottles, can be reused. Glass bottles can be crushed and melted to make different glass products. Other products cannot be reused and so are recycled for a different use.</p> <p>Metals can be recycled by melting and recasting or reforming into different products. The amount of separation required for recycling depends on the material and the properties required of the final product. For example, some scrap steel can be added to iron from a blast furnace to reduce the amount of iron that needs to be extracted from iron ore.</p> <p>Students should be able to evaluate ways of reducing the use of limited resources, given appropriate information.</p> | |

4.10.3.1 Corrosion and its prevention

| <p>Corrosion is the destruction of materials by chemical reactions with substances in the environment. Rusting is an example of corrosion. Both air and water are necessary for iron to rust.</p> <p>Corrosion can be prevented by applying a coating that acts as a barrier, such as greasing, painting or electroplating. Aluminium has an oxide coating that protects the metal from further corrosion.</p> <p>Some coatings are reactive and contain a more reactive metal to provide sacrificial protection, eg zinc is used to galvanise iron.</p> | |

| <p>Most metals in everyday use are alloys.</p> <p>Bronze is an alloy of copper and tin. Brass is an alloy of copper and zinc.</p> <p>Gold used as jewellery is usually an alloy with silver, copper and zinc. The proportion of gold in the alloy is measured in carats. 24 carat being 100% (pure gold), and 18 carat being 75% gold.</p> <p>Steels are alloys of iron that contain specific amounts of carbon and other metals. High carbon steel is strong but brittle. Low carbon steel is softer and more easily shaped. Steels containing chromium and nickel (stainless steels) are hard and resistant to corrosion.</p> <p>Aluminium alloys are low density.</p> | |

4.10.3.3 Ceramics, polymers and composites

| <p>Most of the glass we use is soda-lime glass, made by heating a mixture of sand, sodium carbonate and limestone. Borosilicate glass, made from sand and boron trioxide, melts at higher temperatures than soda-lime glass.</p> <p>Clay ceramics, including pottery and bricks, are made by shaping wet clay and then heating in a furnace.</p> <p>The properties of polymers depend on what monomers they are made from and the conditions under which they are made. For example, low density (LD) and high density (HD) poly(ethene) are produced from ethene.</p> <p>Thermosoftening polymers melt when they are heated. 4.10.4.1 The Haber process

| <p>The Haber process is used to manufacture ammonia, which can be used to produce nitrogen-based fertilisers.</p> <p>The raw materials for the Haber process are nitrogen and hydrogen.</p> <p>Students should be able to recall a source for the nitrogen and a source for the hydrogen used in the Haber process.</p> <p>The purified gases are passed over a catalyst of iron at a high temperature (about 450°C) and a high pressure (about 200 atmospheres). Some of the hydrogen and nitrogen reacts to form ammonia. The reaction is reversible so some of the ammonia produced breaks down into nitrogen and hydrogen:</p> $\text{nitrogen} + \text{hydrogen} \rightleftharpoons \text{ammonia}$ <p>On cooling, the ammonia liquefies and is removed. | <p>Compounds of nitrogen, phosphorus and potassium are used as fertilisers to improve agricultural productivity. NPK fertilisers contain compounds of all three elements.</p> <p>Industrial production of NPK fertilisers can be achieved using a variety of raw materials in several integrated processes. 4.11 Key ideas

The complex and diverse phenomena of the natural world can be described in terms of a small number of key ideas in chemistry.

These key ideas are of universal application, and we have embedded them throughout the subject content. They underpin many aspects of the science assessment and will therefore be assessed across all papers.

These ideas include:

- matter is composed of tiny particles called atoms and there are about 100 different naturally occurring types of atoms called elements
- elements show periodic relationships in their chemical and physical properties
- these periodic properties can be explained in terms of the atomic structure of the elements
- atoms bond by either transferring electrons from one atom to another or by sharing electrons
- the shapes of molecules (groups of atoms bonded together) and the way giant structures are arranged is of great importance in terms of the way they behave
